

Herbicide

Armezon® herbicide is registered for post-emergent applications to flax. Armezon herbicide is an innovative Group 27, post-emergent herbicide that is quickly absorbed by leaves, roots, and shoots to quickly control target weeds.

Active Ingredient: Topramezone - Group 27 | Formulation: Liquid Suspension

One Case Contains: 4 x 600 mL jugs (40 acres per jug) | Crop Staging: 5 - 10 cm

Weed Staging: Broadleaf weeds 1 to 6 leaf and grass weeds 1 to 4 leaf stage

- ¹ Use Merge Adjuvant at 0.5% v/v, i.e. 5 L per 1000 L spray solution.
- ² Use at 1.25% v/v, i.e. 12.5 litres per 1000 L spray solution.
- 3 Use at 1.25% v/v, i.e. 12.5 litres per 1000 L spray solution.
- ⁴ All types including glyphosate-resistant. Apply to kochia less than 10 cm.
- ⁵ All types including glyphosate tolerant. Apply before volunteer canola exceeds the 6-leaf stage.

Water Volume: 10 - 20 gal/ac

Mixing Order:

- 1. Fill sprayer ½ full with clean water and agitate
- 2. Add Armezon herbicide and thoroughly mix
- 3. Add either Merge adjuvant to the spray tank or Assist followed by liquid fertilizer (28% UAN)
- 4. While agitating, fill the remainder of the tank with water up to the proper level

Tank Mixes: DO NOT apply Armezon to flax in combination with any other pesticide or injury may result

Pre-Harvest Interval: 45 days

Follow Crops:

4 months after application: Winter wheat

<u>1 year after application:</u> Alfalfa, canola (inc. Clearfield® canola), field corn, lentils (inc. Clearfield® lentils), navy beans, peas, potatoes, soybeans, spring wheat
